

## Style Revue - Department C

Style Revue entry forms for constructed and purchased garments and narrations are due in the Extension Office by 5 P.M. Thursday, June 26, 2008. Judging is Monday, July 7, 2008. No limit on number of entries in clothing construction style revue. Please check in 15 minutes prior to scheduled time.

### Style Revue - Constructed Garments

#### Division 410

Pay category 5

Four-H'ers may enter more than one project per class number except for class 901. Nightshirts, flannel lounging pants or other types of lounge wear cannot be modeled.

901.\* **Sew for Fun Item** - limit one - 4-H'ers enrolled in Sew for Fun may carry one of their items in the public style revue. They will not be judged. All participants will receive special ribbons and premium.

902.\* **Clothing Level 1**

903.\* **Decorate Your Duds - embellished garments and embellished garments from original design** - Entry must be a garment, not an accessory.

904.\* **Make One/Buy One** – 4-H members enrolled in Knitting, Crocheting, Clothing Level 2, Sewing For You or Tailoring may enter this class. (Knitted or crocheted garments may be combined with a garment the 4-H'er has also sewn or a purchased garment. Please indicate this on the entry form.)

905.\* **Recycled garment**

10. **Decorate Your Duds - garment constructed from original designed fabric**

20. **Clothing Level 2** - The entry must be a complete wearable outfit. No purchased items permitted except accessories (i.e. blouse to go with skirt and vest). See clothing construction exhibits for more information.

**Sewing For You** - The entry must be a complete, wearable outfit except if entry is a non-tailored coat, outerwear jacket. Nightwear or lounge wear cannot be modeled.

30. **Dress**

40. **Skirted Outfit** - skirt with shirt, vest or jacket OR jumper and shirt

50. **Formal** - dress or tuxedo for prom, wedding or other formal occasion

60. **Pants outfit** - pants or shorts with shirt, vest or jacket

70. **Specialty wear** – costume

80. **Sportswear** - jogging outfit, swim wear, aerobic wear, ski wear

90. **Coat/outerwear/jacket** - lined or unlined, non-tailored

**Tailoring** - Additional pieces with blazer, jacket or coat may be either constructed or purchased.

100. **Tailored Blazer or Suit Jacket or Coat**

#### Division 425

Pay category 6

Limit one entry, age 12 and over.

4. **Purchased outfit** - all parts of the outfit must be purchased. An additional information sheet must be completed and submitted at the time of judging.
